




Cap & Trade AB 32 Implementation



Measuring the Climate Impacts of Residential Buildings

- Reviewed, validated, enhanced GHG calculations
- GreenPoint Rated Climate Calculator Version 2



Residential Energy Use and GHG Emissions of Land Use Types

- Simple spreadsheet screening tool
- Calculate GHG reductions of land use strategies



Quantifying GHG Co-Benefits of Commercial Green Buildings

- Database of certified green buildings
- Compare predicted and measured data

Research Underway Support Energy Efficiency Programs

- * Results of research can be used to support implementation of Climate Action Plans
- * ARB will be working with State Agency Review (STAR) Team to update web with research results
- * Evaluate opportunities to include as part of other CAP guidance and tools
