## **Background**

Since 1998, the Carl Moyer Program has provided financial incentives to upgrade vehicles and equipment that achieve emission reductions earlier or greater than those required by regulations. ARB oversees the Carl Moyer Program and publishes the program Guidelines that provides a framework for administering the program, while air districts implement the program based on their local needs and priorities.

SB 513 offers an opportunity to make significant improvements to the program. The legislation was informed through a collaborative process that included public stakeholders and staff from ARB and the local air districts. The collaborative process found that the incentives landscape had changed significantly since the creation of the Carl Moyer Program, and recommended a number of changes to allow the Carl Moyer Program to contribute significant emission reductions alongside implemented regulations, advanced clean technologies, and other incentive programs. SB 513 incorporates many of these recommendations and provides direction to implement them through the guidelines development process.

Several changes have been incorporated already, most notably revisions to provide needed flexibility to fund cleaner school bus projects. Effective on January 1, 2016 the Carl Moyer Program guidelines were modified to provide school districts with additional opportunities for funding to replace the oldest, highest-polluting buses. However, to address the more complex changes introduced by SB 513, additional revisions are required. The workshops are to gather input from the public on potential changes.

## **Changes Under Consideration**

To implement SB 513, the program must be modified to address the following areas:

- Cost-effectiveness values based on the cost of technology and adopted regulations and rules.
- Extension of leveraging opportunities to allow for co-funding of projects with other sources of funds.
- Program guidance for funding infrastructure projects.
- Guidance for funding existing source categories including on-road trucks and buses, off-road equipment, portable and stationary agricultural engines, marine vessels, locomotives, and light-duty vehicles.
- Methods to simplify administration of the program while retaining accountability.

Input is invited on these and any other areas of concern to the public.
